Preface:-

The Government has issued Maharashtra Self-Finance School (Establishment & Regulation Act, 2012) in order to provide qualitative education in the State, generalisation of education, to give approval on permanently unaided basis to new primary, secondary and higher secondary schools and for upgradation of existing schools. This Act has been made applicable with effect from academic year 2013-14. Incidental to this Act, to give approval to new schools and for upgradation of existing schools, applications were invited in Feb 2013. Out of the received 7108 applications 2417 applications have been accepted and made eligible on 15 May, 2013.

2. Considering the shortcomings during scrutiny of the eligible applications and difficulties faced for implementation of the Act, the proposal for amendment in some provisions of the section pertaining to the Act was submitted to the cabinet for approval during the meeting held on 05 June 2013. In the said meeting of the cabinet as per the sanction received for the proposal of the Department, after approval of law and judiciary Department the order in this reference, has been promulgated in the Maharashtra State Gazette after the approval of Honourable Governor on 02 July, 2013

3. As per the provisions of Maharashtra Self-Finance School (Establishment & Regulation Act, 2012), those educational societies who had applied for permission to the new schools and upgradation of the existing schools, however due to non-compliance of the provisions of the Act, their proposals were ineligible. For such societies, after fulfilling the revised provisions in reference to the applications received, incidental to the recommendations of the scrutiny committee with registration of self-explanatory report revised proposals were invited. Accordingly after scrutiny of the received applications 828 applications are made eligible. The matter of further necessary action on these received applications was under consideration with the Government. After consideration of all the facts the Government has take the following decision.

Government Resolution :-

On the above background, for the academic year 2013-14, incidental to the district wise report received for permission of new school or upgradation of existing school from scrutiny committees as per section 6 (1) and incidental to the various provisions of the above Act and the provisions of the order dated 02 July 2013 vide Maharashtra Self-Finance School (Establishment & Regulation Act, 2012) for the academic year 2013-14 out of the total applications received 828 applications are declared as eligible.

- The eligible 191 schools of upgradation are given permission for starting new classes from the academic year 2013-14
- For the proposals of new school, the eligible 637 schools as above are hereby given permission. Each and every school must fulfil the provisions of Right of Children to Free and Compulsory Education Act,

2009. (Except for unaided minority schools). Similarly the above mentioned management of the concerned eligible schools should fulfil the provisions of Right of Children to Free and Compulsory Education Act, 2009 and send application to concerned competent authority for first approval within a period of one month. The concerned authority should ensure that the provisions of Right of Children to Free and Compulsory Education Act, 2009 have been fulfilled (except for unaided minority schools) and then only should take further necessary action for giving first approval.

- 4. The pre-primary schools are not given approval as independent schools but are approved as affiliated to primary schools. Accordingly the schools which will start under this will be given approval from the first Std.
- 5. No changes can be made by the society in the medium prescribed for approval, the place of school etc in the future. In case if the school is started in the place other than the place for which permission has been granted by the Government, then the permission will be automatically treated as cancelled. As per provisions of this Act, the permission granted for starting new school or for upgradation of the existing school will only be for that particular academic year. If the management fails to start the school within a period of eighteen months from such permission, the said permission will be treated as null and void.
- 6. It will be mandatory for the new schools / upgradation schools which are granted permission as given in the statement enclosed to follow the Government orders issued from time to time, work procedure as well as provisions of Right of Children to Free and Compulsory

Education Act, 2009. (Except for unaided minority schools) and the provisions of Maharashtra Self-Finance School (Establishment & Regulation Act, 2012).

- 7. It will be necessary for the member secretary of the scrutiny committee of the concerned district to personally inform the applicants of eligible as well as ineligible proposals alongwith details for starting new schools or for up gradation of the existing schools as per the district wise details given in the statement enclosed. The acknowledgement of the same should be kept in the Government office.
- 8. Regarding the new schools / upgradation schools which are granted permission as given in the statement enclosed, while filling information in the DISE Data, it will be necessary to mention in separate category as recognised self-finance school / obtain Number. The further action regarding this should be carried out by State Project Director, Maharashtra Primary Education Council, Mumbai. Similarly for information of all it will be necessary to display on the outer board of the school as recognised self-finance school.
